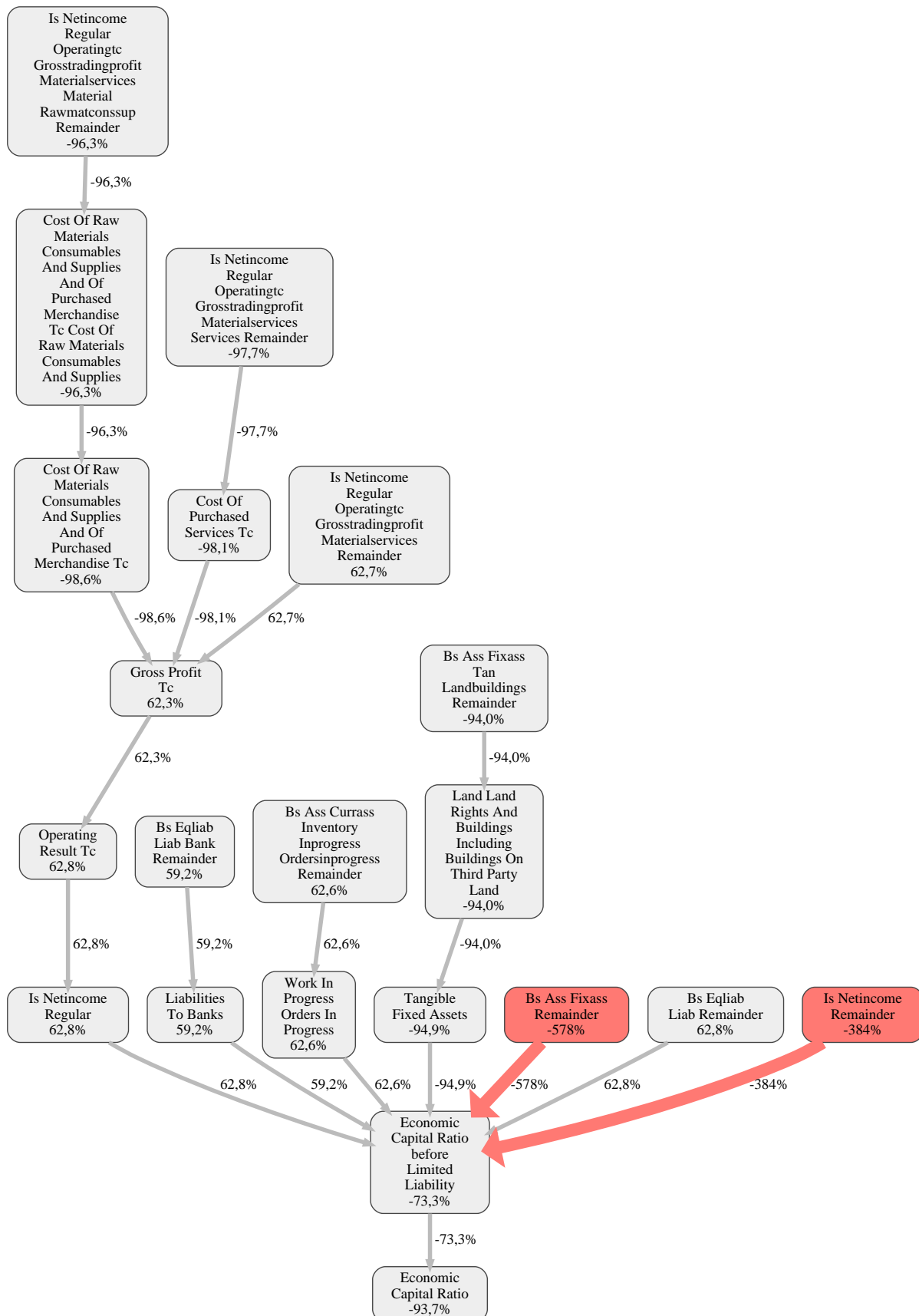

The relative strengths and weaknesses of Eiffage Infra Südwest GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Eiffage Infra Südwest GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Eiffage Infra Südwest GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 578% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 94% points below the market average of 156%.
