



The relative strengths and weaknesses of MAG Gewerbebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MAG Gewerbebau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 103% points. The greatest weakness of MAG Gewerbebau GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 433% points.

The company's Economic Capital Ratio, given in the ranking table, is 103%, being 53% points below the market average of 156%.
