

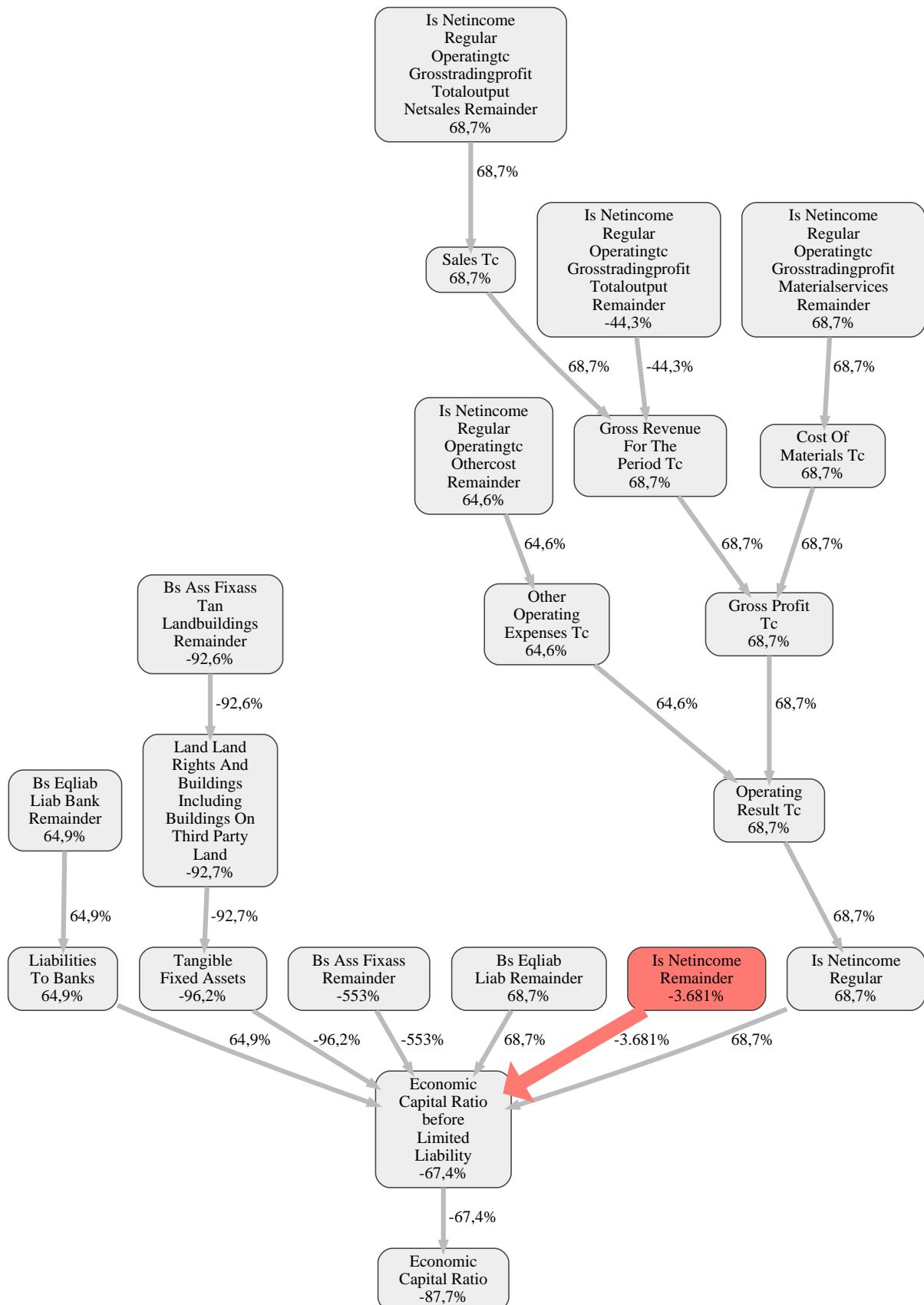

The relative strengths and weaknesses of BK Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BK Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of BK Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 3.681% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 88% points below the market average of 156%.
