



The relative strengths and weaknesses of M Haseitl Baugesellschaft mbH Co Betriebs KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of M Haseitl Baugesellschaft mbH Co Betriebs KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 96% points. The greatest weakness of M Haseitl Baugesellschaft mbH Co Betriebs KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 676% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 60% points below the market average of 156%.
