





The relative strengths and weaknesses of Baugeschäft Neve GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Baugeschäft Neve GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Baugeschäft Neve GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 601% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 100% points below the market average of 156%.
