



The relative strengths and weaknesses of Hofschröder Projektbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hofschröder Projektbau GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 41% points. The greatest weakness of Hofschröder Projektbau GmbH Co KG is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 657% points.

The company's Economic Capital Ratio, given in the ranking table, is 41%, being 115% points below the market average of 156%.
