

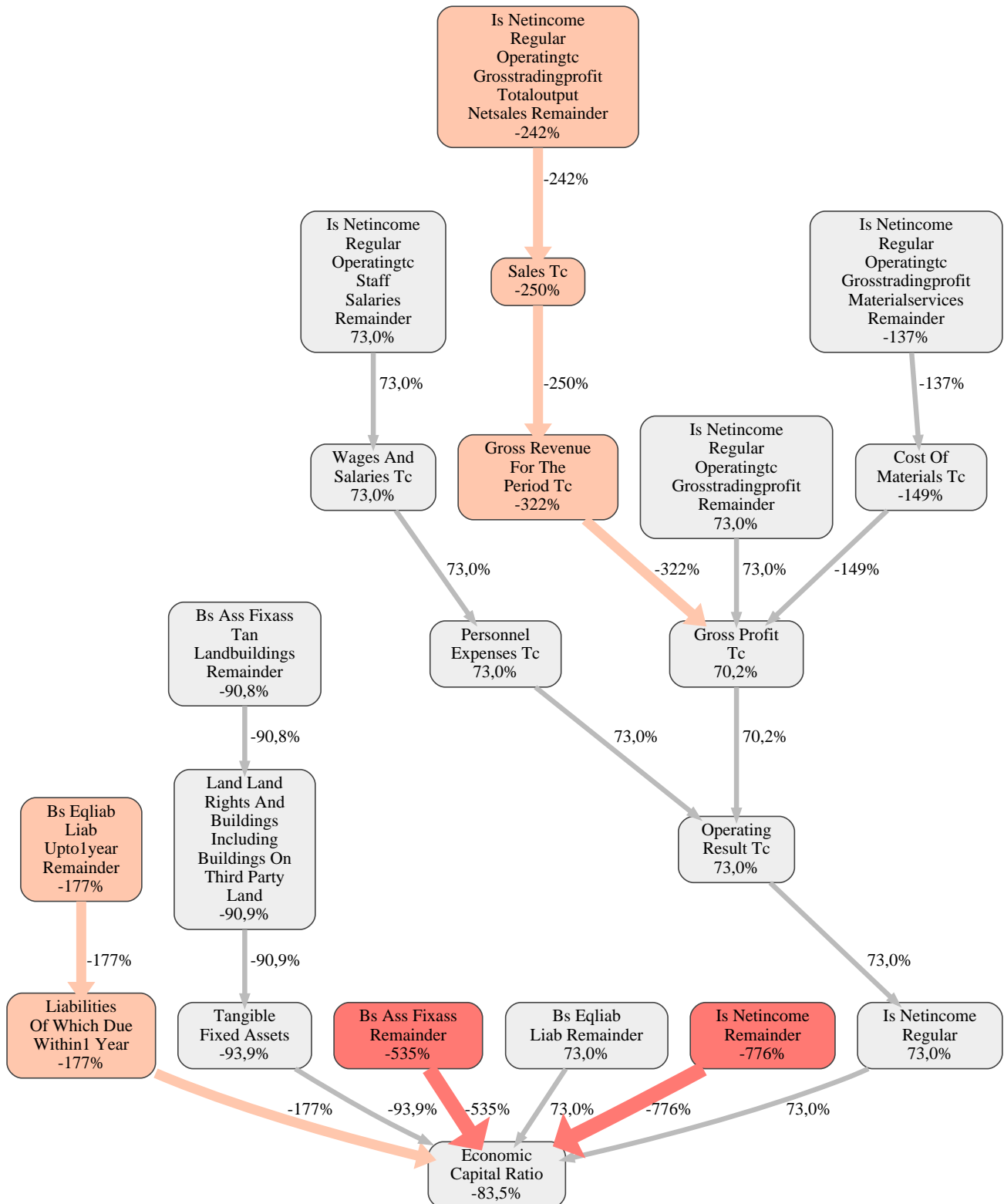

The relative strengths and weaknesses of GD Bau UG Haftungsbeschränkt are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GD Bau UG Haftungsbeschränkt compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 73% points. The greatest weakness of GD Bau UG Haftungsbeschränkt is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 776% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 83% points below the market average of 156%.
