



The relative strengths and weaknesses of Guggenberger GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Guggenberger GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 149% points. The greatest weakness of Guggenberger GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 265% points.

The company's Economic Capital Ratio, given in the ranking table, is 149%, being 7,4% points below the market average of 156%.
