

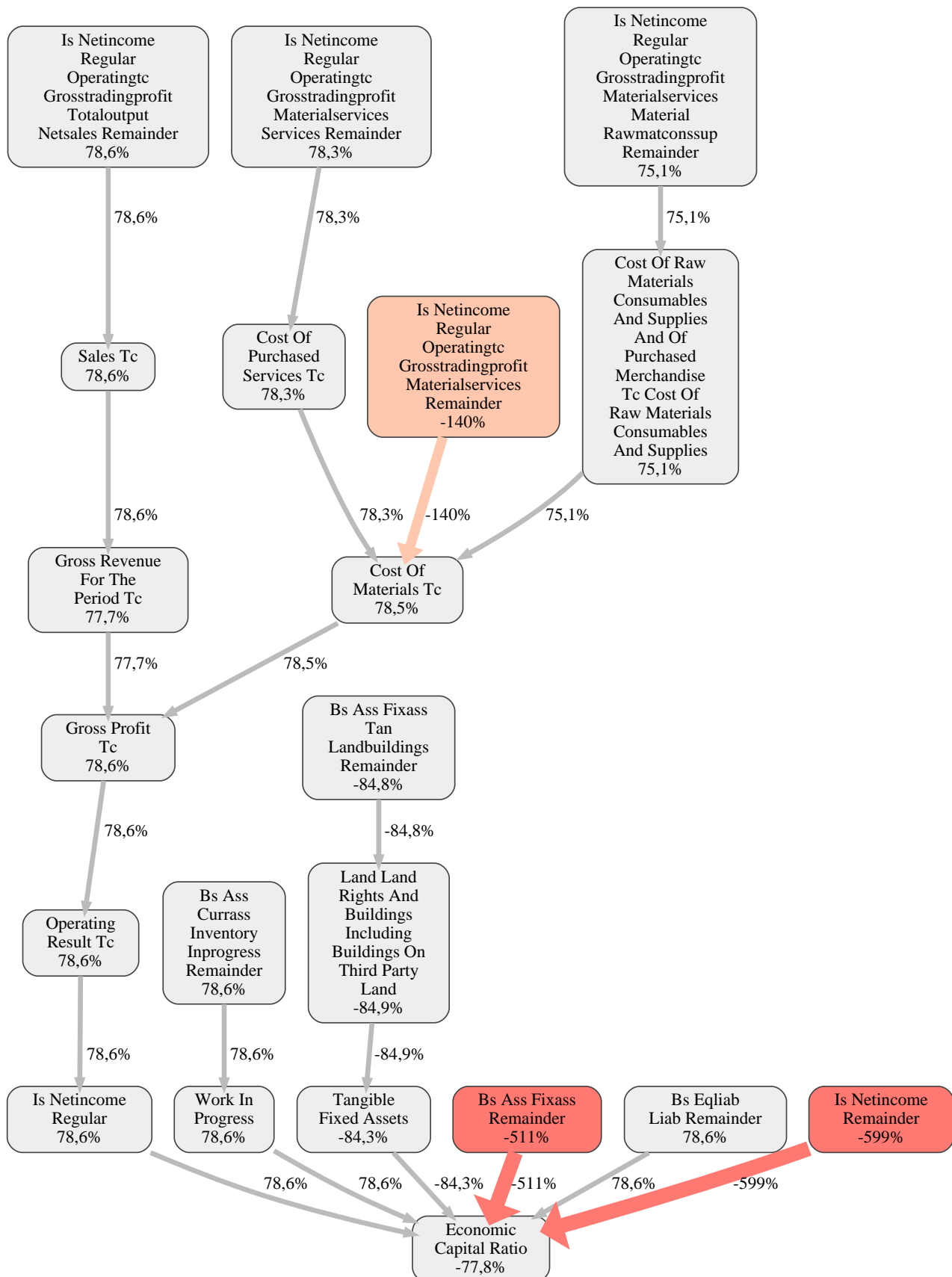

The greatest strength of Anton Schick GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Anton Schick GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 599% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 78% points below the market average of 156%.
