



The relative strengths and weaknesses of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 621% points.

The company's Economic Capital Ratio, given in the ranking table, is 52%, being 105% points below the market average of 156%.
