



The relative strengths and weaknesses of Josef Rädlinger Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Rädlinger Ingenieurbau GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 165% points. The greatest weakness of Josef Rädlinger Ingenieurbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 731% points.

The company's Economic Capital Ratio, given in the ranking table, is 165%, being 8,5% points above the market average of 156%.
