

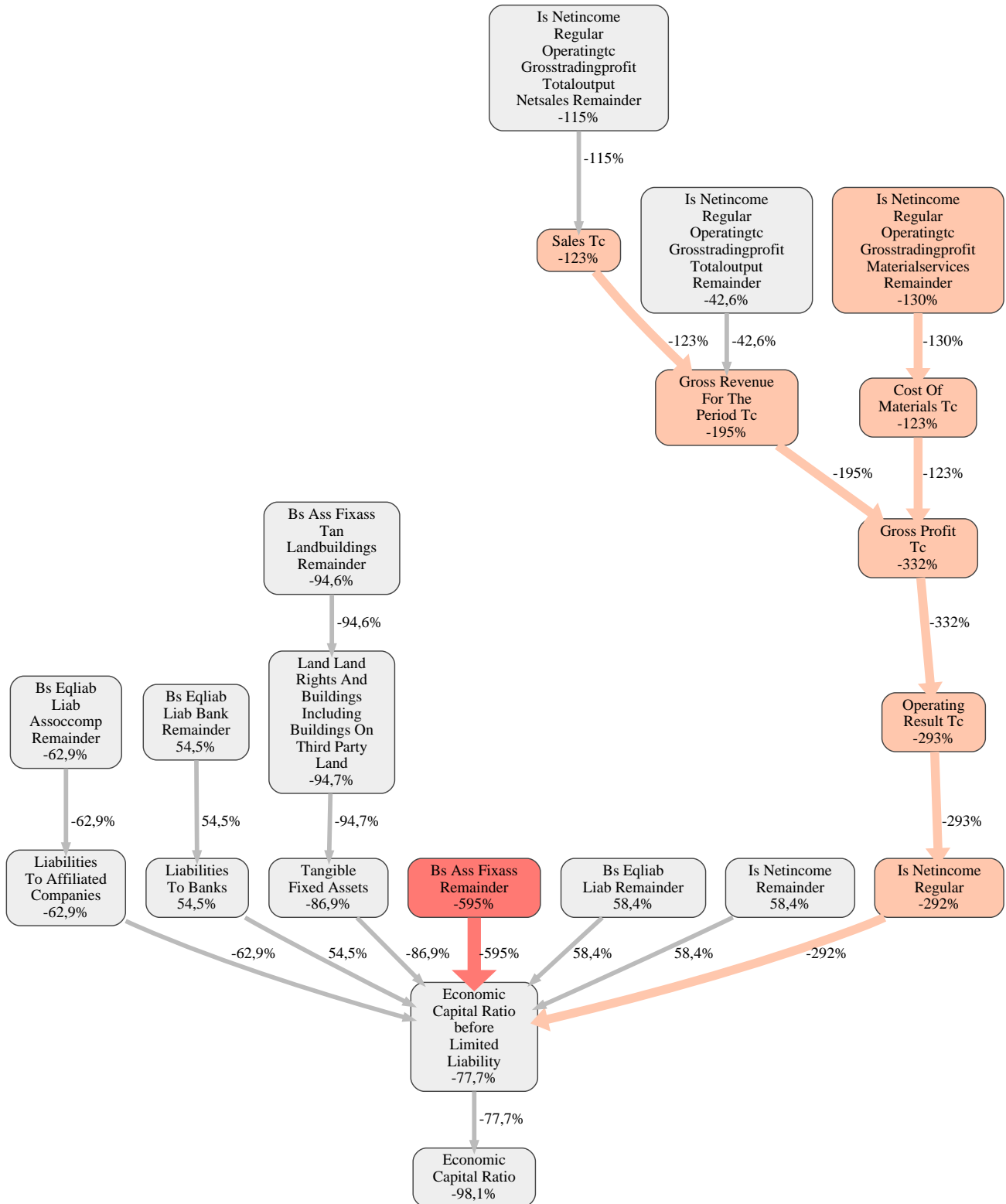

The relative strengths and weaknesses of Josef Rädlinger Kiesbaggerei und Fuhrunternehmen GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Rädlinger Kiesbaggerei und Fuhrunternehmen GmbH Co KG compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Josef Rädlinger Kiesbaggerei und Fuhrunternehmen GmbH Co KG is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 595% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 98% points below the market average of 156%.
