



The relative strengths and weaknesses of Kleusberg Holding GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kleusberg Holding GmbH Co KG Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 127% points. The greatest weakness of Kleusberg Holding GmbH Co KG Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 333% points.

The company's Economic Capital Ratio, given in the ranking table, is 127%, being 30% points below the market average of 156%.
