



The relative strengths and weaknesses of Michael Klebl GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Michael Klebl GmbH Co KG Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 169% points. The greatest weakness of Michael Klebl GmbH Co KG Konzern is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 1.947% points.

The company's Economic Capital Ratio, given in the ranking table, is 169%, being 13% points above the market average of 156%.
