



The relative strengths and weaknesses of PORR Oevermann GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PORR Oevermann GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 100% points. The greatest weakness of PORR Oevermann GmbH Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 662% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 57% points below the market average of 156%.
