



The relative strengths and weaknesses of Gemeinnützige Wohnungsbaugesellschaft mbH Wuppertal Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gemeinnützige Wohnungsbaugesellschaft mbH Wuppertal Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Gemeinnützige Wohnungsbaugesellschaft mbH Wuppertal Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 599% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 99% points below the market average of 156%.
