



The relative strengths and weaknesses of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 152% points. The greatest weakness of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 515% points.

The company's Economic Capital Ratio, given in the ranking table, is 152%, being 4,4% points below the market average of 156%.
