



The relative strengths and weaknesses of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of WBM Wohnungsbaugesellschaft Berlin Mitte mit Beschränkter Haftung Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 512% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 78% points below the market average of 156%.
