



The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 463% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 64% points below the market average of 156%.
