



The relative strengths and weaknesses of Wohnbau Mainz Gesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau Mainz Gesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 45% points. The greatest weakness of Wohnbau Mainz Gesellschaft mit Beschränkter Haftung Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 643% points.

The company's Economic Capital Ratio, given in the ranking table, is 45%, being 111% points below the market average of 156%.
