



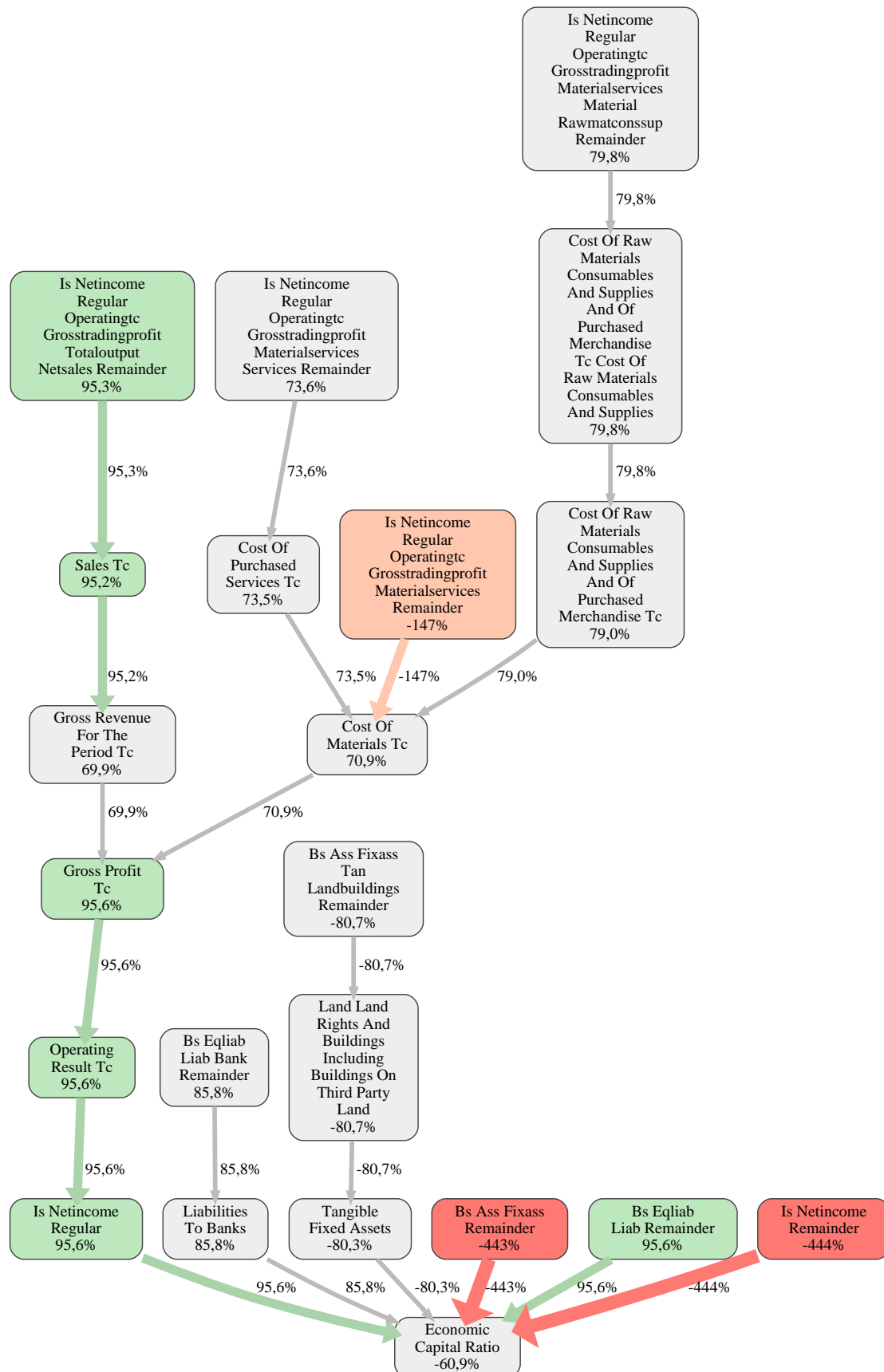

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 96% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 444% points.

The company's Economic Capital Ratio, given in the ranking table, is 96%, being 61% points below the market average of 156%.
