The greatest strength of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 162% points. The greatest weakness of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 463% points.

The company's Economic Capital Ratio, given in the ranking table, is 162%, being 5,9% points above the market average of 156%.
