



The relative strengths and weaknesses of August Prien Verwaltung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of August Prien Verwaltung GmbH Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 93% points. The greatest weakness of August Prien Verwaltung GmbH Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 454% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 64% points below the market average of 156%.
