

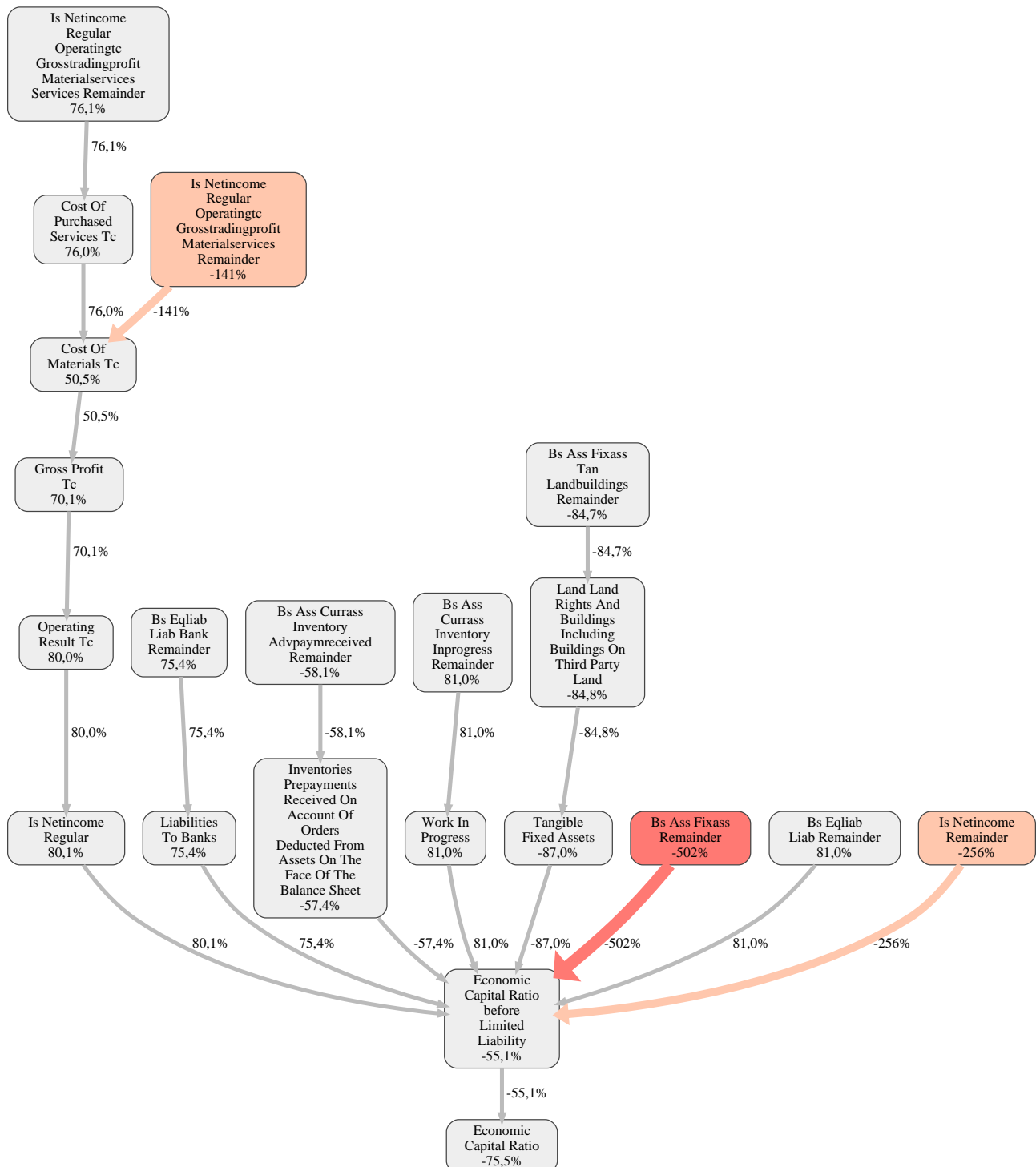

The relative strengths and weaknesses of Adam Hörnig Baugesellschaft mbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Adam Hörnig Baugesellschaft mbH Co KG Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Adam Hörnig Baugesellschaft mbH Co KG Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 502% points.

The company's Economic Capital Ratio, given in the ranking table, is 81%, being 75% points below the market average of 156%.
