



The relative strengths and weaknesses of Bickhardt Bau SE Vormalis Bickhardt Bau Aktiengesellschaft Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bickhardt Bau SE Vormalis Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Bickhardt Bau SE Vormalis Bickhardt Bau Aktiengesellschaft Konzern is the variable Bs Ass Fixass Remainder, reducing the Economic Capital Ratio by 434% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 58% points below the market average of 156%.
