



The relative strengths and weaknesses of H E Holding GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of H E Holding GmbH Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 160% points. The greatest weakness of H E Holding GmbH Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 518% points.

The company's Economic Capital Ratio, given in the ranking table, is 160%, being 3,9% points above the market average of 156%.
