The relative strengths and weaknesses of Gewobau Erlangen Wohnungsbaugesellschaft der Stadt Erlangen mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gewobau Erlangen Wohnungsbaugesellschaft der Stadt Erlangen mit Beschränkter Haftung Konzern compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Gewobau Erlangen Wohnungsbaugesellschaft der Stadt Erlangen mit Beschränkter Haftung Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 486% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 68% points below the market average of 156%.
