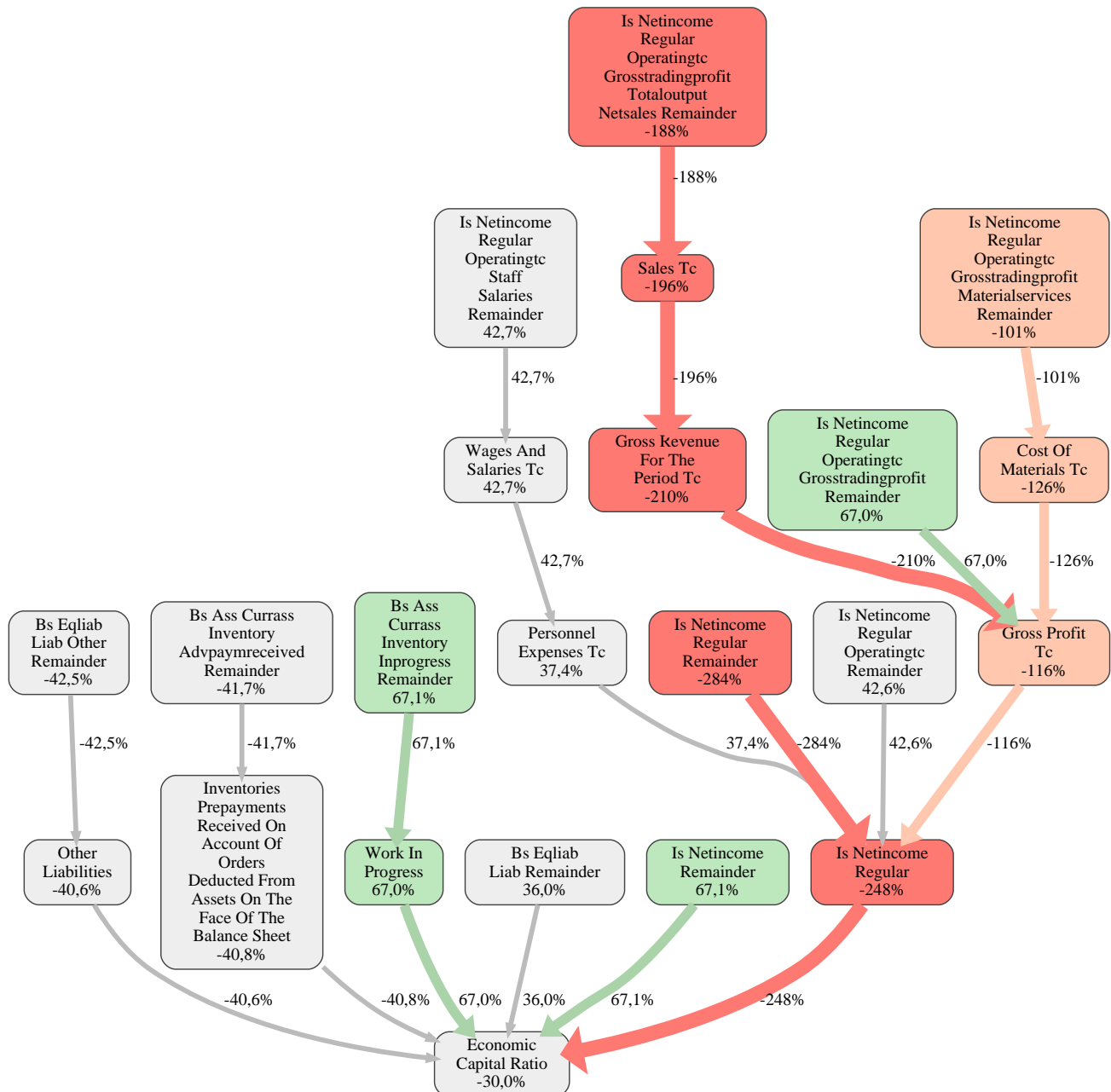

The greatest strength of Lambert Schlun GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Lambert Schlun GmbH Co KG is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 30% points below the market average of 97%.
