



The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 118% points. The greatest weakness of Bateg GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.228% points.

The company's Economic Capital Ratio, given in the ranking table, is 118%, being 21% points above the market average of 97%.
