



The relative strengths and weaknesses of B O Bau und Projekte GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Bau und Projekte GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 123% points. The greatest weakness of B O Bau und Projekte GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 864% points.

The company's Economic Capital Ratio, given in the ranking table, is 123%, being 26% points above the market average of 97%.
