The greatest strength of Otto Wulff Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 142% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 920% points.

The company's Economic Capital Ratio, given in the ranking table, is 142%, being 45% points above the market average of 97%.
