



The relative strengths and weaknesses of THB Tief und Hausbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of THB Tief und Hausbau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 149% points. The greatest weakness of THB Tief und Hausbau GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 232% points.

The company's Economic Capital Ratio, given in the ranking table, is 150%, being 53% points above the market average of 97%.
