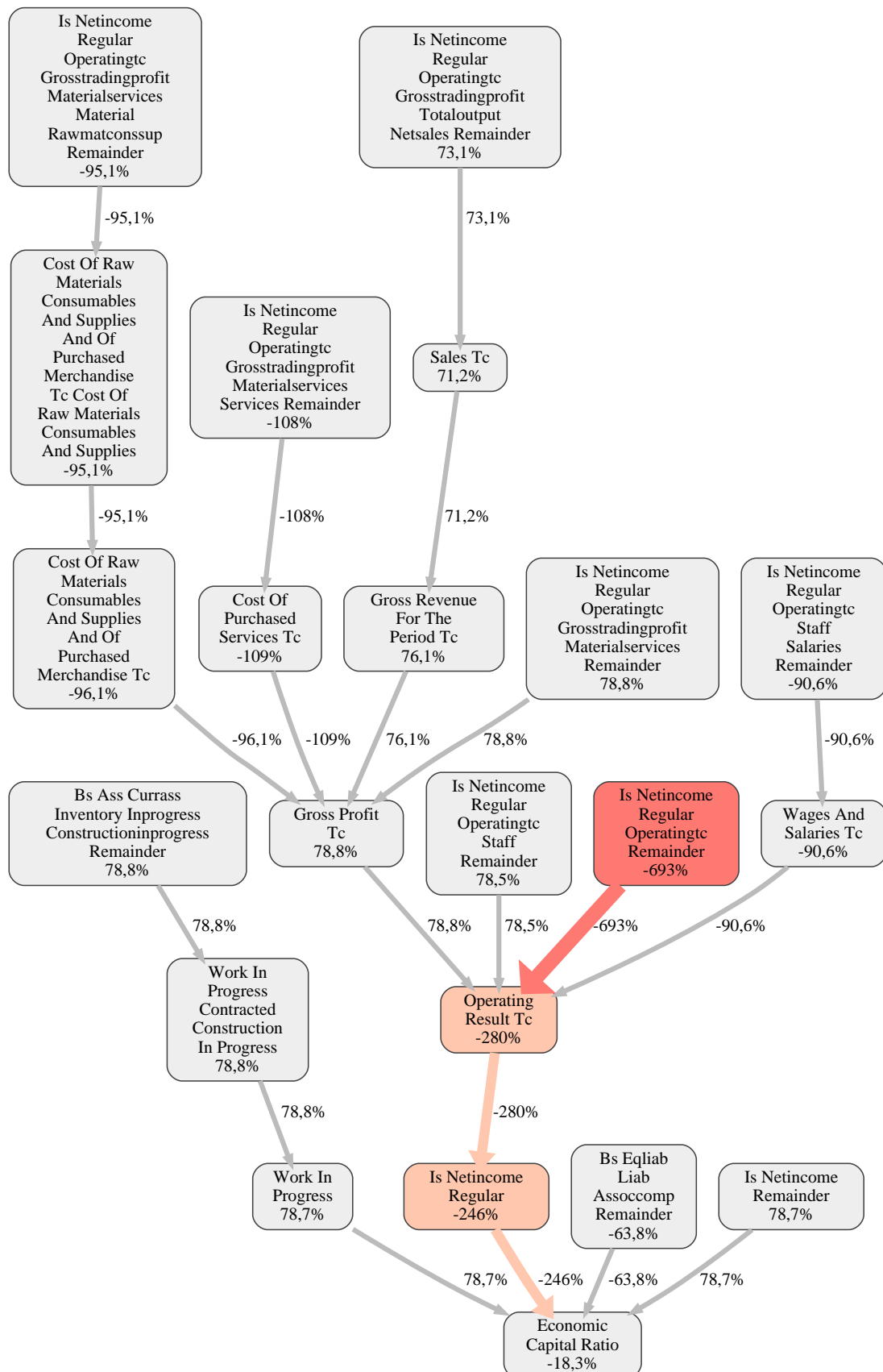

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 693% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 18% points below the market average of 97%.
