



The relative strengths and weaknesses of Sax Klee GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Sax Klee GmbH Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Sax Klee GmbH Bauunternehmung is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 280% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 0,31% points above the market average of 97%.
