

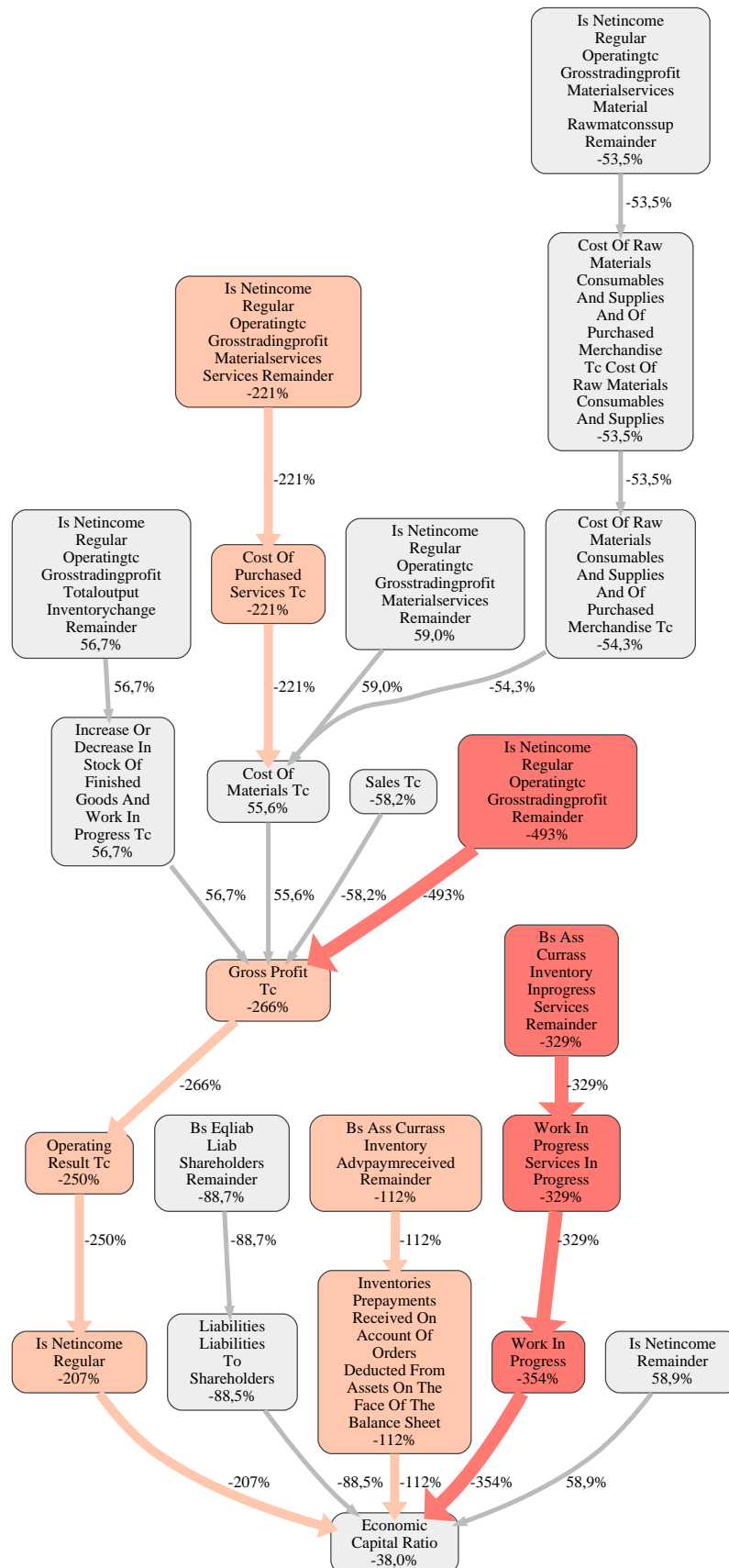

The greatest strength of Brunner Co Baugesellschaft mbH Co München compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Brunner Co Baugesellschaft mbH Co München is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 493% points.

The company's Economic Capital Ratio, given in the ranking table, is 59%, being 38% points below the market average of 97%.
