



The relative strengths and weaknesses of Josef Randlshofer Sohn Hoch und Tiefbauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Randlshofer Sohn Hoch und Tiefbauunternehmen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Remainder, increasing the Economic Capital Ratio by 183% points. The greatest weakness of Josef Randlshofer Sohn Hoch und Tiefbauunternehmen GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 537% points.

The company's Economic Capital Ratio, given in the ranking table, is 187%, being 90% points above the market average of 97%.
