



The relative strengths and weaknesses of Joseph Hubert Bauunternehmung GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Joseph Hubert Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Joseph Hubert Bauunternehmung GmbH Co KG is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 209% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 32% points below the market average of 97%.
