



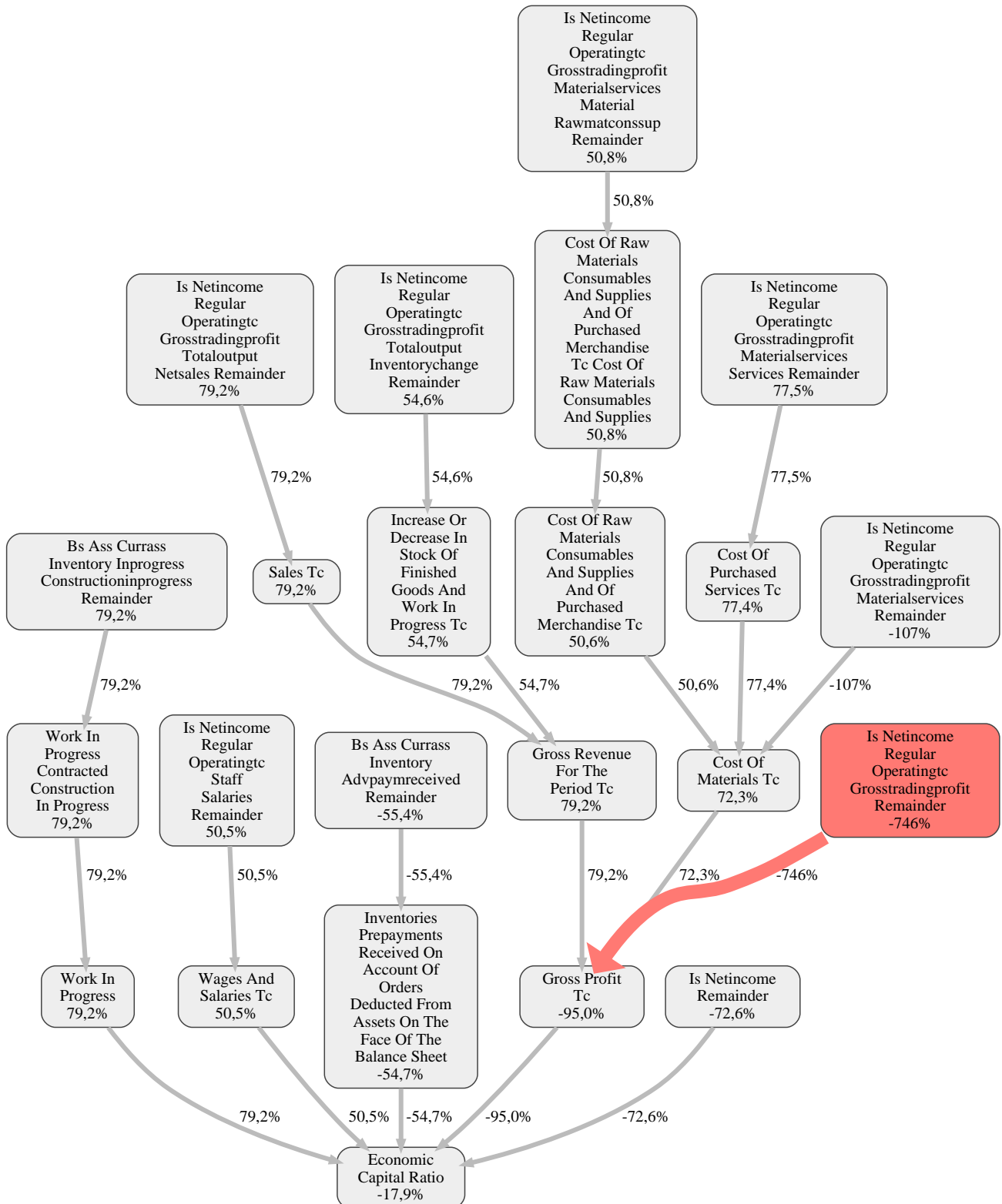

The greatest strength of Bauunternehmung Hofschröer GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Bauunternehmung Hofschröer GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 746% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 18% points below the market average of 97%.
