



The relative strengths and weaknesses of Dittgen Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dittgen Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Dittgen Bauunternehmen GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 532% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 4,2% points below the market average of 97%.
