



The relative strengths and weaknesses of Arda Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arda Bau GmbH compared to the market average is the variable Bs Ass Currass Remainder, increasing the Economic Capital Ratio by 155% points. The greatest weakness of Arda Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 939% points.

The company's Economic Capital Ratio, given in the ranking table, is 155%, being 58% points above the market average of 97%.
