



The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 360% points. The greatest weakness of Schrobsdorff Holding AG is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 4.541% points.

The company's Economic Capital Ratio, given in the ranking table, is 360%, being 263% points above the market average of 97%.
