



The relative strengths and weaknesses of Schmeing Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schmeing Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 169% points. The greatest weakness of Schmeing Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.400% points.

The company's Economic Capital Ratio, given in the ranking table, is 169%, being 71% points above the market average of 97%.
