



The relative strengths and weaknesses of Finsterwalder Bau Union GmbH Sitz Zeckerin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Finsterwalder Bau Union GmbH Sitz Zeckerin compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 96% points. The greatest weakness of Finsterwalder Bau Union GmbH Sitz Zeckerin is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 934% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 10,0% points above the market average of 97%.
