



The relative strengths and weaknesses of Tempel Bau Nord GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tempel Bau Nord GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Tempel Bau Nord GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 293% points.

The company's Economic Capital Ratio, given in the ranking table, is 59%, being 38% points below the market average of 97%.
