



The relative strengths and weaknesses of Harfid GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Harfid GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 42% points. The greatest weakness of Harfid GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 248% points.

The company's Economic Capital Ratio, given in the ranking table, is 42%, being 55% points below the market average of 97%.
