



The relative strengths and weaknesses of HBG Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBG Bau GmbH compared to the market average is the variable Bs Ass Fixass Fin Sharesinaffil Remainder, increasing the Economic Capital Ratio by 18% points. The greatest weakness of HBG Bau GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 241% points.

The company's Economic Capital Ratio, given in the ranking table, is 18%, being 79% points below the market average of 97%.
