The greatest strength of Werner Wohnbau GmbH Co KG compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 161% points. The greatest weakness of Werner Wohnbau GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 438% points.

The company's Economic Capital Ratio, given in the ranking table, is 161%, being 64% points above the market average of 97%.
