



The relative strengths and weaknesses of Cadolto Fertiggebäude GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Fertiggebäude GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 24% points. The greatest weakness of Cadolto Fertiggebäude GmbH Co KG is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 68% points.

The company's Economic Capital Ratio, given in the ranking table, is 24%, being 73% points below the market average of 97%.
