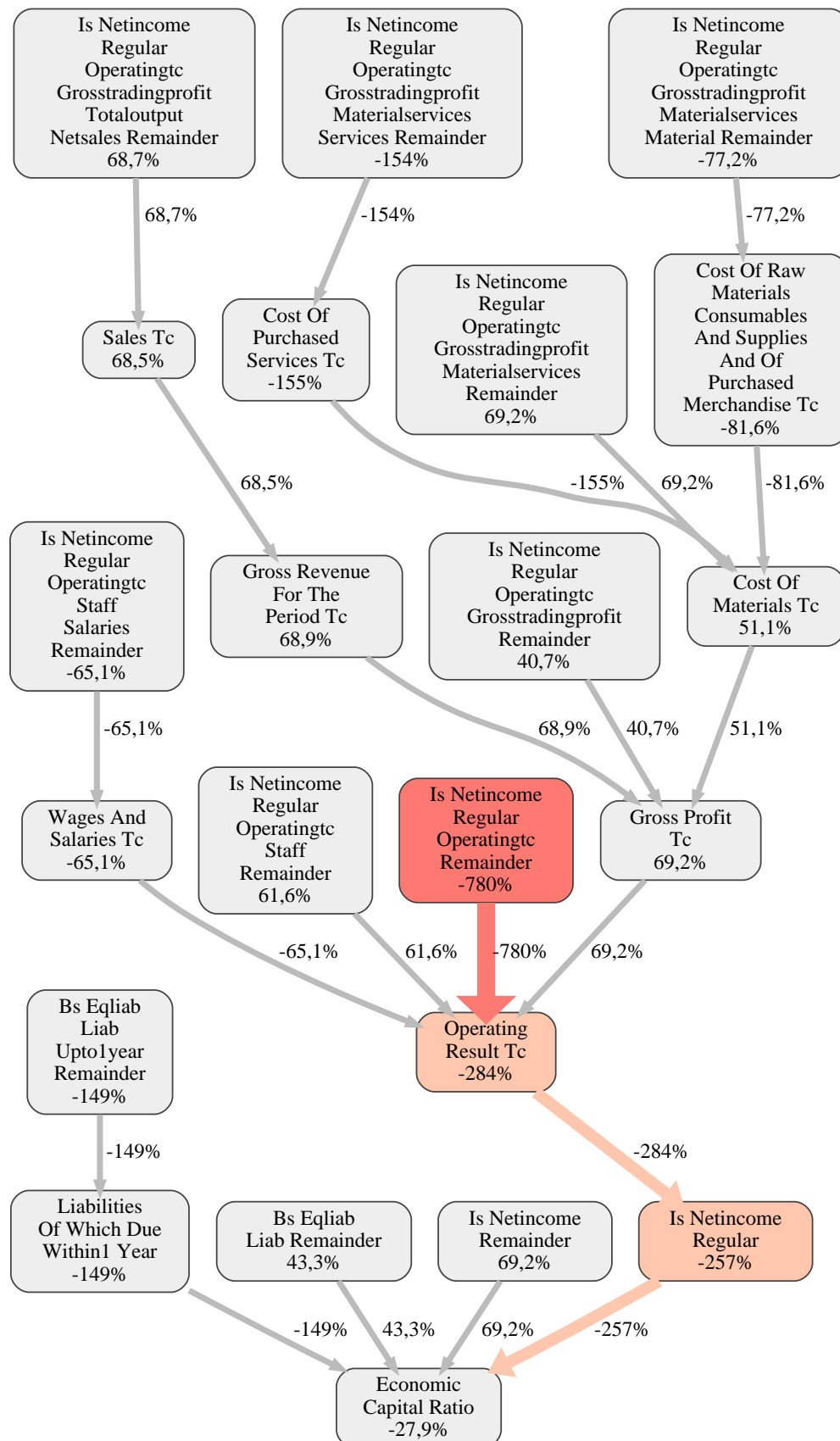

The relative strengths and weaknesses of Bien Zenker GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bien Zenker GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Bien Zenker GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 780% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 28% points below the market average of 97%.
