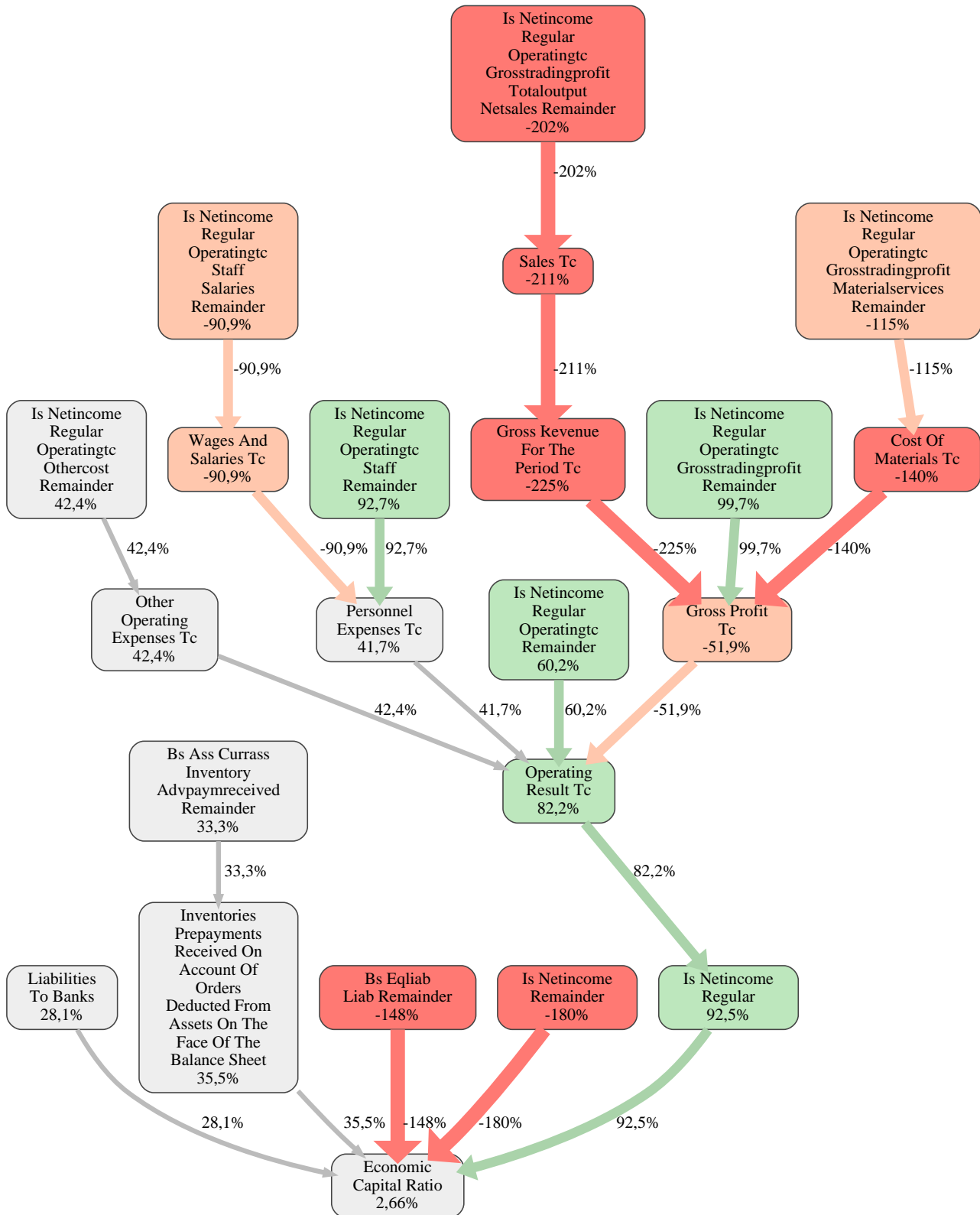

The greatest strength of Jökel Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 100% points. The greatest weakness of Jökel Bau GmbH Co KG is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 225% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 2,7% points above the market average of 97%.
